## **Relief of Poverty**

- To relieve poverty by operating a food bank for individuals and families residing in Lincoln who are living in poverty, of low income or are in need.
- Provide basic necessities of life including: food, clothing, access to shelter, and assistance with obtaining affordable housing.
- Offer supportive services and programs that relieve financial pressures and improve food security and housing stability including but not limited to: utility relief, rent support, information and referrals to other service providers.
- Advocate for the needs and best interests of Lincoln's residents who are facing economic hardship.
- Undertake other complementary purposes not inconsistent with these purposes.

### Notes:

- ✓ The new language is a combination of what was recommended by ONCA, accurately depicts our purpose and is also lifted from updated Articles of another Niagara Food Bank.
- ✓ Two bullets from the original Purposes have been omitted on the amendments as they are in our Bylaws and not required to be in our Articles per ONCA.
  - To purchase, lease, erect, construct, build or otherwise acquire, own operate or use buildings and other facilities necessary to conduct the said objectives and activities; and

## **Purposes and Provisions Sections of Articles**

## **Original – CCWN Description of Purposes in Articles:**

Lincoln Community Care is a non-profit charitable organization comprised of volunteers. Its objects are:

- To assist the underprivileged families, the sick, the physically, emotionally, mentally or financially disadvantaged single, the handicapped, the needy migrant farm works and the unemployed in the community;
- To provide supportive services and program to the needy people for their health, welfare and care, including, but not limited to: counselling services, emergency food, medication, clothing, shelter, fuel and furniture, and assisting in obtaining affordable housing for needy persons;
- To serve as a liaison with public service agencies and provide information to the community at large regarding the services available, and the needs of physically, mentally, emotionally disadvantaged individuals in the community;
- To purchase, lease, erect, construct, build or otherwise acquire, own operate or use buildings and other facilities necessary to conduct the said objectives and activities; and
- To accept donations, gifts, legacies and bequests.
